### Processing of personal information

#### Information That We Collect

# Your Rights

You have the right to view any personal information that Jaytag holds about you, including:

- How long we intend to store your personal data for
- If we did not collect the data directly from you, information about the source

You also have the right to request erasure of your personal data or to restrict processing (where applicable) in accordance with the data protection laws; as well as to object to any direct marketing from us. Where applicable, you have the right to data portability of your information and the right to be informed about any automated decision-making we may use.

If we receive a request from you to exercise any of the above rights, we may ask you to verify your identity before acting on the request; this is to ensure that your data is protected and kept secure.

# Sharing and Disclosing Your Personal Information

We do not share or disclose any of your personal information without your consent, other than for the purposes specified in this notice or where there is a legal requirement. Data processors acting on our behalf with whom we do share your data will only process your data in accordance with instructions from us and comply fully with this privacy notice, the data protection laws and any other appropriate confidentiality and security measures.

# Safeguarding Measures

Jaytag takes your privacy seriously and takes every reasonable measure and precaution to protect and secure your personal data. We do this through the use of information technology data security techniques and internal operating procedures.

#### Transfers Outside the EU

Personal data in the European Union is protected by the General Data Protection Regulation (GDPR) but some other countries may not necessarily have the same high standard of protection for your personal data. Jaytag computer make use of data processing services outside the EU for the following purposes:

- Storage of technical information relating to your IT setups
- Backups of technical information

Aside from these purposes, Jaytag does not transfer or store any personal data outside the EU without your consent.

# How Long We Keep Your Data

Jaytag only ever retains personal information for as long as is necessary and we have strict review and retention policies in place to meet these obligations. We are required under UK tax law to keep your basic personal data (business name, address, contact details) for a minimum of 6 years after which time it will be destroyed. Where you have consented to us using your details for direct marketing, we will keep such data until you notify us otherwise and/or withdraw your consent.
